As a condition of using our services for your pets, the following Waiver & Assumption to Hold Harmless must be signed:

Photographs: I understand that photographs, video or digital recordings are taken of the facility, pets, customers and staff on a regular basis for, among other things, use in advertising by Next Level Kennels. I acknowledge that all such images, together with prints and copyrights, therein are the property of Next Level Kennels. I give Next Level Kennels my consent, permission, and authorization, without compensation to me, to use, reproduce, and alter the images, in print and electronic format (including the Internet), either alone or in combination with other texts and graphics. I waive my right to approve the finished photograph, advertising copy, print material or electronic files that may be used in conjunction with the images.

By choosing to utilize the services, participate in activities, groom or board my pet(s) at Next Level Kennels, I agree to the following:

- I agree to pay the rates that are in effect at the time my pet is at Next Level Kennels, full payment is required at check in. I am aware that extra charges may be incurred and I agree to pay them at the time of pick-up. Examples include, but are not limited to: extended boarding and grooming.
- I understand that on entering Next Level Kennels my pet will be examined for fleas. If fleas are found, a natural flea repellent bath will be administered at my expense.
- Owner further agrees that the pet shall not leave the kennel until the charges are paid in full.
- Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.
- If my pet appears to be ill, I authorize Next Level Kennels to engage the services of a veterinarian at my expense, to give other requisite attention, and to make whatever decisions are required for my pet's veterinary treatment. I agree to pay all veterinary charges incurred by my pet while in the care of Next Level Kennels. I will not hold Next Level Kennels liable for failure to seek veterinary attention or for decisions made under this contract.
- All charges incurred by Owner shall be payable up pick-up of pet. Next Level Kennels shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from boarding pet at the kennel. The owner hereby agrees that in the event the boarding charges are not paid when due in accordance with this contract, the Kennel may exercise its lien rights upon 10 days written notice given by kennel to owner by certified mail to address shown on contract. Kennel may dispose of pet for any and all unpaid charges, at, and not limited to, private or public sale, in the sole discretion of the kennel, and owner specifically waives all statutory or legal rights to contrary. If such sale shall not secure a price adequate to pay such costs of board or other charges Delinquent, plus costs of sale, then the Owner shall be liable to kennel for the difference. All monies realized by Next Level Kennels at such sale, over and above the charges due and cost of sale, shall be paid by the Kennel to the Owner.
- I understand that Next Level Kennels will exercise all due diligence and care in the guardianship of my pet. I hereby waive and release Next Level Kennels owners and agents from any and all liability of any nature, for injury or damage, including that which may result from the action of any dog including my own, and I expressly assume the risk of such damage or injury while my dog participates in or attends any function of Next Level Kennels, while on the grounds or the surrounding area thereto.
- Upon signing this agreement, the owner agrees to abide by this contract from the date signed and includes any future dates that the kennel services are used by the owner.
